Competitors will shoot five consequitive strings of four steel targets plus a stop plate. Worst string is eliminated and remaining times totaled with lowest time winning. Shooters will compete in one of four divisions based on IPSC divisions of Open, Standard, Production and Revolver.

Stages will pay cash prizez on Calaway system of an amount based on\$2.00 per stage per compeitor plus added money from sponsors. Number of pays based on number of competitors in each division

Match open to all shooters of known ability. Match Directors decision final.

#### Skeena Valley Steel Rules

Firearms: Pistol or Revolver

Caliber: 9mm or larger

Divisions: Open, Standard, Production and Revolver (based on IPSC

definition)

Holster/Magazine postition not restricted. Magazind capacity restricted by law only.

#### **Targets**

Stop plate will be different color from remainder of plates. Target colors may vary from match copy' Targets will be painted after each competitor.

#### **Penalties**

A five second penaly will be added to the recorded time for each target not engaged when stop plate is hit.

#### Safety

All competitors and spectators must wear Eye and Ear protection. Cash Awards

Pays are based on \$2.00 per shooter per stage from entry plus added money from sponsors pro-rated by number of shoters per division per stage.


Stage: 1 Pit: 1

for all passes.






Stage: 2 Pit: 2 Name: And a Mini Popper to Stop

Start/Proceedure: In Box A, Hands above shoulder all passes






Stage: 3 Pit: 3

Start/Proceedure: In Box A, Hands above shoulder all passes






Stage: 4 Pit: 3
